**NOTA 1.- INFORMACIÓN GENERAL**

La Fundación Copservir no ha sufrido ningún cambio en cuanto a su constitución inicial, miembros fundadores, objetivos generales y específicos y sus entes administrativos.

**NOTA 2.- INFORMACIÓN CONTABLE**

El software y todos los documentos soporte de la información contable se encuentran debidamente archivados en la oficina de comunicaciones de la Dirección General de Copservir.

A continuación se analizan en detalle todos los rubros que componen tanto el Balance General, como el Estado de Resultados, así:

**ACTIVOS**

**a.- ACTIVO CORRIENTE**

La Caja General presenta un saldo de \$149.329 que obedece a unos excedentes de cheques girados para la compra de útiles, ropa y regalos para los niños beneficiarios de la fundación. Este dinero será consignado en la cuenta del Banco Santander.

Todas las donaciones recibidas a través de los puntos de venta de Drogas La Rebaja, son consignadas en la cuenta del Banco Santander.

**b.- DEUDORES**

Los saldos por consignar de cada sucursal obedecen a los recaudos del mes de diciembre.

Con la Dirección General de Copservir se firmó un convenio en el mes de Marzo para que a partir de esa fecha la Cooperativa entregara en calidad de donación la suma de \$3.500.000 mensuales, pero a la fecha solo habían hecho el desembolso correspondiente a los tres primeros meses (Marzo-Abril y Mayo). Por tanto a 31 de diciembre adeudan la suma de \$24.500.000 pertenecientes a los siete meses restantes.

En la cuenta por cobrar a terceros se registran dos rubros. El primero se refiere a un cheque girado por \$300.000 con el fin de abrir una cuenta a nombre de la Fundación en la ciudad de Bucaramanga, pero a la fecha no ha sido posible que el Banco autorice dicha apertura. Aunque el trámite se hizo en el mismo banco donde la fundación tiene su cuenta corriente en la ciudad de Cali.

El segundo rubro son \$500.000 que fueron girados a nombre de la señora Delcy Patricia Acevedo en la ciudad de Bucaramanga para cubrir los gastos de una actividad a realizar con los niños de esa ciudad. Pero los dineros utilizados para esa actividad fueron descontados de los recaudos en los puntos de venta. Por consiguiente la señora Acevedo hará el reembolso del dinero en los próximos días.

#### **c.- PROPIEDAD, PLANTA Y EQUIPO**

La Fundación adquirió unas muletas por \$60.000 y una silla de ruedas de \$277.778 con el fin de poder facilitarlas en calidad de préstamo a las personas que las necesiten por un período corto de tiempo.

#### **d.- DIFERIDOS**

El único activo diferido con el que cuenta la Fundación es el software contable, al cual para el año gravable 2009 se aplicó una amortización equivalente a \$580.000.
